Minutes of the meeting for April 27, 2021 Zoom Meeting hosted by Miss Utility in Hanover, MD Prepared by Susan Sullivan

CALL TO ORDER AND INTRODUCTIONS

Chairman Kevin Woolbright called the regular monthly meeting to order at 9:32 a.m. via Zoom. There were 50 virtual attendees and 7 attendees onsite.

APPROVAL OF MINUTES

A motion to approve the March 23, 2021 minutes was made by Dora Parks (DPC Secretary) and seconded by Mark Hamrick (DPC Vice Chairman). The motion carried by approval.

OLD BUSINESS

No old business to report.

NEW BUSINESS

Jennifer Arroyo was introduced as Miss Utility's new call center manager. She has been with OCC for 24 years serving in various positions of leadership and expertise. Welcome Jennifer!

MD Authority Locator Seat: The Damage Prevention Committee will soon be accepting nominations for the MD Authority Locator Seat. This seat is currently being filled by Authority Chairman, Erik Phillips (Utiliquest) whose second, two (2) year term is up in September. Among other requirements, all nominees must reside in Maryland, be committed to damage prevention, and know MD Title 12 law. Once nominations have been vetted, a selection will be made and the selected nominee will be notified, by letter, this October. Dora Parks will provide the Maryland locating stakeholders with nominating information within the next few weeks.

OPEN DISCUSSION

Joe Shelton (BF Joy) started the discussion by complimenting George Daffan (Utiliquest) who assisted recently in getting a locate marked and completed ahead of an expected delay.

There was a lengthy discussion on the (SB877) Code 5 law changes. Jim Barron confirmed that an agreed upon marking schedule must be documented prior to a Code 5 (Not Complete/In Progress) being statused on a ticket. Dora Parks suggested the code 5 locator comments field be used for the SB0877 required documentation; if the excavator who receives a copy of the Ticket Check status disagrees with the comments, they can process a code 7 DISPUTE. As a confirmation after further inquiry, a code 5 cannot be prohibited from locator use and permission to use the 48-hour delay status by an excavator, is not required. Furthermore, a documented Code 5 status, on a valid ticket can be excavated on as long as the area of excavation has been marked per the agreement.

Chuck Baker (Verizon) continued the discussion by asking if a Code 5 drop-down menu could be developed that would assist with locator response. Scott Brown indicated it would be considered and further suggested that this might also be a way to force a locator to provide documentation prior to the Ticket Check code's submission.

Dora Parks complimented Mark Hamrick's team (Verizon) for resolving a homeowner issue that was brought to her attention and went on to express the call center's gratitude to all of those who participate in assisting our communities when concerns arise, help is requested and said concerns are resolved.

In response to excavator concerns over no response 48-hour delays and tickets expiring without positive response, Mike Burns (Utiliquest) assured everyone that Utiliquest and BGE were committed and working diligently to address these on-going issues. Measures include extending many work schedules to 7 days-a-week; aggressively bringing on and training new hires; bringing in out of state assistance and doing everything possible to get locates done. He asks that he be contacted directly with further questions and concerns.

MISS UTILITY CALL CENTER

- ➤ ITICnxt: Susan Sullivan (Miss Utility) provided an overview of ITICnxt's Advanced Search feature. This feature allows a user to find an excavation area, for mapping purposes, using multiple approaches. These include: Entering an address, an intersection or a named building, park, hospital, or school in the address field; using GPS coordinates, a previous ticket number or by simply zooming in on a known location on the map itself.

- ➤ Dashboard Reporting: Dora Parks provided ticket volume data for the month of March 2021
 - Inbound ticket volume: 95,412 a monthly increase of 25.522% compared to 2020
 - Outbound volume: 628,032 a year-to-date increase of 38.315% compared to 2020
- ➤ Damage Reporting: Dora Parks provided YTD data through March 2021 of reported damages in MD/DC.
 - 177 utility damages (40 mains and 137 services)
 - 27.68% due to no call or valid ticket
 - 28.25% due to hitting a marked line
 - 36.72% due to incorrect locate marks
 - 7.34% due to other root causes

MARYLAND AUTHORITY Jim Barron, Executive Director

There was an Open Meeting and a Closed Executive Authority Zoom Meeting on April 7, 2021

- The Authority reviewed five (5) NPVs.
 - o Fines were recommended along with one (1) Policy Letter Requirements and four (4) Damage Prevention Trainings Requirements.

- The Authority asked Susan Stroud to get an estimate on the cost of creating an Authority Member only portal on the website that would allow Authority Members to review documents prior to a scheduled meeting.
- Jim Barron participated in sessions with PEPCO and Gray & Sons to review key updates to Title XII effective March 11, 2021.

MARYLAND TITLE 12 RE-WRITE Jim Barron, Executive Director

- Chapter 18, Senate Bill SB 877 officially became law on March 11, 2021.
